

From the endorsements on the writ of error it appears that it was received by the sherill of Suwannee county on the 17th day of February, 1889, and was executed March 17th, 1890, by delivering a copy to the Clerk of the Circuit Court for Suwannee county, and at the same time reading to him the ori, rinal. The acts of the sheriff of Suwannee county were in his capacity of sheriif of that county, and not as deputy of the sheriff of this court. There is also the following endorsement on the writ of error, over the signature of the Clerk of the Circuit Court of Suwannee county, ciz: The execution of this writ appears by the certified transcript now on file in the Supreme Court.
